1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Government College of Art and Craft, Calcutta is one of the oldest and premier institutes of art education in India. Boasting about 157 years legacy, the college has always been a seat of academic excellence. GCAC is a co-educational seat of learning and affiliated to University of Calcutta. Currently the institution follows the Choice Based Credit System (C.B.C.S.) for its undergraduate programmes. From 2005 the institution has also commenced the doctoral degree programme (Ph.D.) in Fine Arts. It is the only fine arts institution in the country to offer a specialized course in Indian painting. The institution has received an 'A' from the NAAC accreditation committee in 2007.

Located at the historic Chowringhee neighbourhood of Kolkata (formerly Calcutta) and adjacent to the Indian Museum, the college is spread over 1.58 acres of eco-friendly land. It is well connected by bus, taxi and underground metro railway. The college is a thriving space for intellectual and artistic exchange.

Exhibitions, workshops, film-screenings, special lectures, cultural events, sports, and many other events are organized frequently. The Annual Exhibition and Annual Social along with the Alumni Day have come up as a winter fest in Kolkata for decades, where artists, connoisseurs, art lovers all visit the college campus. An excursion to sites of historic and cultural importance has been conducted on a regular basis. The student matters have been successfully represented by the members of Student's Union which has always been an apolitical representative body; a healthy feature, seldom found in Kolkata college campuses.

The landmarks of central Kolkata: Indian Museum, Asiatic Society, Victoria Memorial, Academy of Fine Arts, Rabindra Sadan, St Paul's Cathedral, Birla Planetarium, Maidan, Park Street and New Market all are located in the vicinity of the campus. An in house canteen is operational in the campus. Students common rooms and a small playground inside the premises is available for sports and recreation.

Vision

- specialised medium; exuberance of imaginative and creative fervour).
- Approbation of giving maximum freedom in consistent experimentation and ceaseless exercising with the form and content and taking an endeavour to realise the self-assertion.

Our illustrious authority consider that attainment of all these qualification and understanding with these components will be enable an artist to be acquainted properly with the repertoire of indigenous art and cultural heritage and consequently he/she cognize effectively the quintessence of Tagore's ideals of art evaluation, that corresponds, "...art represents the inexhaustible magnificence of creative spirit, it is generous in its acceptance and generous its bestowal..."

Mission

This art institution has specific goals, objectives, and focus areas. The primary facie is to promote, support, and celebrate the beauty and aesthetics of art in various forms. This art institution fosters creativity, cultural appreciation, and artistic expression within the community it serves. Through exhibitions, performances, educational programs, educational tours and community outreach, the institution aims to enrich the lives of individuals, inspire artistic exploration, and contribute to the cultural fabric of society.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

The institutional strength of this art institution refers to its overall capacity, resources, and characteristics that contribute to its effectiveness, reputation, and ability to fulfil its mission.

Faculty and Staff: We have strong faculty which consists of experienced and respected artists, designers, scholars, and educators who are passionate about teaching and mentoring students.

Academic Programs: We have a well-designed programs that offer a balanced combination of theoretical knowledge, technical skills, and artistic exploration that provide students with a comprehensive education.

Exhibitions: We have classrooms which are converted to galleries, and performance venues to provide students with opportunities to showcase their work and engage with the broader artistic community.

Alumni Engagement and Success: The achievements and success of alumni reflect the strength of this art institution. Engaged and successful alumni contribute to the institution's reputation and act as ambassadors in the art world. The institution foster a strong alumni network and maintain connections with former students through events, mentorship programs, and career support.

Institutional Weakness

- 1. As an art institution of historical value, we are unable to connect with other contemporary institution of education. There is little scope for us to collaborate and share the experiences of our historic contributions as well as contemporary art practices with other art as well as liberal art institutions.
- 2. As GCAC is the only institution under University of Calcutta which provides visual art as its curriculum

there is no option to directly collaborate with other universities or institutions.

3. Under the present scenario it is important to connect with several institutions which imparts art education of contemporary value. This interaction is often not possible because of infrastructural inadequacy.

Institutional Opportunity

- 1.We are looking forward to experiment with New Media and Technologies which will allow to explore new artistic expressions.
- 2.Individuals at this institution now addresses pressing social, political, and environmental issues in the artwork. They are encouraged to work on topics which includes climate change, social justice, human rights. These works often speaks as dialogue and contribute to social change and foster a more inclusive and sustainable society.
- 3. Collaborations between artists and other institutions may foster a global exchange of ideas and perspectives.

Institutional Challenge

Inadequate number of teaching staff as well as large number of vacancy among the Group C & Group D non-teaching staff.

We lack in procurement of modern and appropriate computer equipment, software, and networking infrastructure.

We lack in developing an Online Database of Rare Books that are part of our vast library collection. The vast number of rare books that need restoration & preservation also needs to be done immediately.

We lack a permanent librarian who can lend out books to students.

We lack in other modern practical accessories and tools for other disciplines.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

- 1. **Foundation Course:** This courses is designed to provide students with a broad understanding of art fundamentals. These courses include drawing, painting, sculpture, art history, color theory, composition, and design principles.
- 2. **Specialization Course:** These specialisations include areas such as fine arts, illustration, graphic design, photography, ceramics, printmaking, textile design, modelling & sculpture, printmaking, design wood and leather. Individuals choose the track that aligns with their artistic passion and goals at the time of admission.

- 3. **Studio Practice:** A significant portion of the curriculum in this art college is dedicated to studio practice. Students engage in hands-on creative work within their chosen discipline. They have access to studio spaces, equipment, and materials specific to their area of focus. Studio courses allow students to develop technical skills, experiment with different mediums, and express their artistic vision.
- 4. **Art History and Theory:** Art history and theory provide students with a comprehensive understanding of the historical and theoretical contexts of art. It helps to explore various art movements, artists, cultural influences, and critical perspectives. Studying art history and theory helps students develop a deeper appreciation for the artistic heritage and broaden their perspectives.
- 5. **Display and assessments:** It is an essential component of art college curricula. During the practical display sessions, students present their work in front of examiners and peers for feedback and constructive criticism. Critiques help students refine their artistic vision, improve their technical skills, and develop a critical eye.
- 6. **Electives and Interdisciplinary Studies:** GCAC provide opportunities for students to take elective courses or engage in interdisciplinary studies. These options allow students to explore different areas of art and design beyond their specialization, such as multimedia arts, digital arts, art education, art therapy, and printmaking. Electives and interdisciplinary studies help students broaden their skill set and gain a well-rounded perspective.
- 7. **Exhibition Opportunities:** GCAC provide exhibition opportunities for students to showcase their work to the public and gain exposure.'Parampara', Student's Annual exhibitions take place within the college campus ,giving students a chance to share their artistic vision with a broader audience and receive feedback from professionals and art enthusiasts.

Teaching-learning and Evaluation

Assessments : Portfolios assessments during the semester examinations is a common method. A committee of faculty/s, professional artists from related field or industry professionals review and evaluate students' artwork based on diverse criteria like technical skill, creativity, subjectivity, concept development, intellectual capabilities and overall artistic growth.

After each class assignments, as per the norms prescribed in the syllabus, a group of internal teachers evaluate the student's work, keeping in mind both their class outputs and their attendance for the particular class. At the end of each semester, both internal faculties, and externals who are expert in the discipline/subjects are invited to evaluate the semester round student's art works. T

Presentations and Feedbacks: Students present their artwork and participate in critical discussions where they receive feedback from instructors, or visiting faculties from other institutions.

Student's Annual Exhibition: Every year, the students get the opportunity to exhibit their artworks in the annual exhibition titled as "Parampara" which provides an opportunity to present their work to a larger public. The exhibition appears an as encouraging opportunity to the students inviting both appreciative and critical feedbacks, from the viewers and art connoisseurs.

Written Assignments: Assignments such as, research articles, dissertation papers, artist's note and reflective

essays helps in assessing students' ability to articulate and develop critical thinking aptitude. This kind of assignments also helps in understanding their grasp over the language, their understanding of art history and theory, and their ability to contextualize their own work within a broader artistic and cultural framework at Post graduate level.

Practical Assignments: Students under CBCS system at UG level undergo practical interdisciplinary assignments where they are required to complete specific artistic tasks or projects within a given timeframe.

Multidisciplinary Works: At the post graduate level students are instructed to do multidisciplinary works where they learn specificities of a subject/discipline other than their opted stream. This assignment helps them to learn not only specific artistic tradition but also to interact with professionals who are experts in their individual field.

Research, Innovations and Extension

We offer 8 courses in PG (MFA) level which include dissertation papers in their curriculum. Students are required to undertake research projects, write analytical essays, or explore theoretical concepts related to their artistic practice. These activities promote critical thinking, research skills, and the ability to articulate ideas about art.

Infrastructure and Learning Resources

Infrastructure and learning resources in this art college play a crucial role in providing students with the necessary tools, spaces, and technology to enhance their artistic skills and knowledge.

- 1. **Studios and Workspaces:** GCAC provide studio spaces where students can work on their art works. These studios are partially equipped with various tools, equipments, and materials specific to different artistic disciplines. Students have limited access to photography labs, digital media labs.
- 3. **Exhibition Spaces and Galleries:** GCAC have exhibition spaces and galleries where students can showcase their work to the college community and the public during the Annual exhibitions. These spaces allow students to gain experience in preparing, curating, and presenting their art in a professional manner. They also provide opportunities for students to interact with visitors and receive feedback on their work.
- 4. **Libraries and Resource Centers:** GCAC has an extensive collection of rare art-related books, journals, periodicals. These resources cover a wide range of topics such as art history, art theory, techniques, contemporary art and other areas. We do not have an online databases as of now. We are looking forward to create digital archives, and image repositories for research purposes in near future.
- 5. **Computer Labs :** Lab at GCAC is partially equipped with computers, specialized software for digital art, graphic design, animation, and multimedia production. Students have partial access to these facilities due to the inadequate number of accessories.
- 6. **Audio-Visual Facilities:** GCAC have only two (2) smart classrooms which provide audio-visual facilities for students.

- 7. **Printmaking and Photography Labs**: We have fewer dedicated lab equipped with darkrooms, printing presses, developing equipment, and other specialized tools.
- 8. **Online Learning Platforms:** We do not have any online learning platform as of now but we can initiate such program in near future if directed from the concerned end.

Student Support and Progression

In order to guarantee that students have a rewarding and successful educational experience, Government College of Art & Craft, Calcutta places a high priority on student assistance and growth.

- 1. **Academic Advising:** Faculties play a crucial role in helping students navigate their academic journey. They assist students in their practical training, understanding degree requirements, and planning their academic progression.
- 2. **Professional Development:** We offer resources and workshops focused on professional development. This includes topics featuring industry professionals, contemporary artists who provide valuable insights into career paths and opportunities in the art world.
- 3. **Internship and Work Placement Opportunities:** We initiate drives for IT companies to place our students.
- 4. **Exhibition and Presentation Opportunities:** Providing students with opportunities to exhibit their work within the college or in external venues can be instrumental in their artistic development and progression. IQAC and Student's union organize Student's Annual exhibitions, where students can display their work to the public. These events foster a sense of accomplishment, encourage peer collaboration, and build confidence in presenting and promoting their artistic endeavours.

Governance, Leadership and Management

Government College is a government college affiliated to University of Calcutta and is governed by Higher Education Dept.Govt of West Bengal.We follow the prescribed rules and decoram as directed from the concerned authority.

Institutional Values and Best Practices

- 1. Socially Engaged Art: Socially engaging and oriented artistic practises are encouraged and supported amongst the students by the Government College of Art and Craft in Kolkata. This is further extended by inviting eminent and professional artists' to present at "SaanjhKahon" (a series of lectures and discussions presentation), who discuss their ideas and artwork that highlight their concerns regarding societal issues. We have the honour of attending lectures given by well-known artists like Atul Dodiya, Bose Krishmachari, Isabella Nardi, K.S. Radhakrishnan, and others at regular intervals.
 - 2. Workshops and educational tours—To enhance the skills and knowledge of cultural traditions of the

country, various batches of students of GCAC, the institution organizes workshops, seminars, symposiums and Educational Tours at a regular basis. Students from our college have recently travelled to Himalayan locations to paint the scenic beauty of the mountains in watercolours as well as engage with the local community.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

The Government College of Art and Craft, Calcutta offers seven specializations at the UG level & eight specializations at the PG level; each strictly specific to various fields of study in the visual arts. However, it also combines these different artistic disciplines, techniques and media at various levels studio practice of the course which in turn results in a more holistic understanding of the visual arts. The results of this approach of involving collaboration and the use of different skills and techniques from various specializations as well as other arts such as music, dance, theater, literature, film and multi-media can be witnessed in semester based practical displays as well as during the Student's Annual Exhibition every

	year. Multidisciplinary activities as elective subjects have already been initiated in CBCS system and we are looking forward to introduce more number of subjects along with industry based training for individuals to explore new creative possibilities and to break down traditional boundaries between different artistic disciplines.
2. Academic bank of credits (ABC):	No such programme has been initiated so far, but the college may introduce such type of programme in the near future.
3. Skill development:	All courses of this institution is essentially based on skill development. This college offers specializations which involve a varied range of types of skills to create and explore new possibilities in UG and PG courses. We are now looking forward to introduce new curriculum for individuals in near future to provide more opportunities.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	Even though there are no specific online courses, the teaching of the vernacular language and cultural studies are part of the curriculum in a very strong way. All semesters have theoretical subjects that are primarily based on world culture as well as Indian culture.
5. Focus on Outcome based education (OBE):	The Government College of Art and Craft, Calcutta offers seven specializations at the UG level & eight specializations at the PG level; each strictly specific to various fields of study in the visual arts with the view to ensure that students should acquire necessary skills and knowledge.
